# Award Categories

## 1. Sustainability in Business Award

**\$1000 + framed certificate**

For innovative schemes undertaken, facilitated or planned by Business and Industry whether they be simple or complex, that strives to improve the quality of the environment or contribute to sustainability or nature conservation in Townsville. This may be in relation to energy or water savings, environmental designs for the tropics, water quality, pollution control, or an environmental product or service.

## 2. Individual Initiative Award

**Framed certificate and Prize Package**

For an individual who has made a significant contribution towards environmental protection and improvement in Townsville. This is an award of recognition of a community member who has worked tirelessly to improve our local natural environment. Examples include dedication to environmental programs, volunteer time on environmental projects, working with and leading the community on environmentally based projects. All nominations are accepted and Townsville City Council encourages people to nominate a person that they feel deserves the award.

## 3. Community Group Award

**\$1000 + framed certificate**

For a community group that has made a significant contribution towards environmental improvement, nature conservation or sustainability in Townsville. Example projects are restoring local vegetation, environmental monitoring, community education, ecological fire management, water quality etc.

## 4. Primary School Award

**\$500 + framed certificate**

For projects, programs or plans which foster environmental awareness and involvement for Townsville Primary students. This may be in relation to native vegetation restoration, recycling, energy savings, water quality, sustainability, wildlife programs etc.

## 5. High School Award

**\$500 + framed certificate**

For projects, programs or plans which foster environmental awareness and involvement for Townsville Secondary students. This may be in relation to native vegetation restoration, recycling, energy savings, water quality, sustainability, wildlife programs etc.

# Conditions of Entry

**Awards will apply only to activities within the Townsville City Council jurisdiction.**

Entries for **Categories 1, 3, 4, and 5** should be submitted in the form of a poster or sculpture that represents what the project is about. A separate A4 page (maximum 2 pages) is to be submitted with a short project description, plans and a statement of the environmental benefits to support the poster or sculpture, plus a brief description of how you would spend the prize money on environmental activities if you won. For planned projects it is a requirement that the prize money is utilised for the project submitted.

Entries for **Category 2** should be submitted in the form of A4 text with photographs and plans (where appropriate) with a maximum of 4 pages explaining the achievements of the individual in the environment.

Planned Project Entries should be submitted in the form of A4 text outlining the proposed project including proposed activities, outcomes, community involvement, budget outline and the environmental benefits of the proposed works, start and completion dates. Drawings can be included to support the application.

Please limit application text to a maximum of 4 A4 pages.

Consideration may also be given to an idea or plan which has been progressed to the point of implementation.

Entries relating to planned projects must demonstrate a high level of preparation and networking and be required to report back to council on the success of the project within 2 months of completion.

Townsville City Council may invite entries and will display and may publicise all entries considered for the Awards as well as the winners at Eco Fiesta 2005.

The decision of the Judging Panel is final.
